1 Guideline

The training positions of the IAAS Internship Program have the following specifics:

- 1.1 Positions are available for 1-2 months
- 1.2 Positions are either paid or non-paid
- 1.3 Positions are full-time and remote working
- 1.4 Interns are not entitled to annual leave or time off during the internship

3 Qualifications:

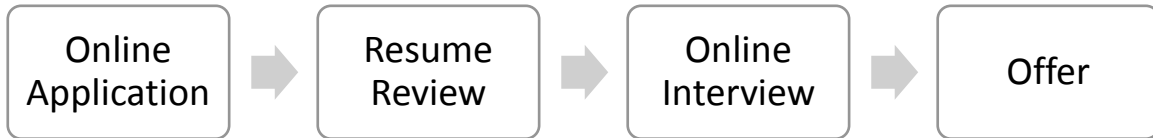
3.1 Education:

- 3.1.1 Current undergraduate or graduate students in a bona fide educational institution at the time of application, or recent graduates.
- 3.1.2 Related fields of study in Agriculture.

3.2 Language:

- 3.2.1 If English is not your first language, you will have to provide relevant document to the English language requirements: Minimum 6.0 (with a minimum of 6.0 in reading and writing and 5.5 in listening and speaking) in IELTS or score level above 650 in TOEIC.

5 Documents

- Current Curriculum Vitae (CV) – in Word version with color photo.
- Letter of Objectives for the internship – in Word version.
- Official Attendance letter from the university or the graduate certificate

6 Tasks for internship- Sustainable Agriculture Development Overview

- 6.1 Select one or two techniques/ projects/ researches/ policies in your home country and complete a report for maximum 15 pages.
- 6.2 The reports includes the sustainable agriculture development overview in your home country, selected subject's development and current situation, 5 years forecast report for the selected subject and cooperation proposal with IAAS.

7 Internship Obligation

- 7.1 The intern will perform the duties outlined in the Internship Agreement at a high standard and with all due skill, care and attention with regard to the level of the knowledge, experience or education the intern has represented to IAAS he or she possesses.
- 7.2 Stay in regular contact with IAAS and respond to all communication from IAAS within two business days.

8 Internship Description

- 8.1 During the first weeks of the internship, one-hour online meeting will be held to learn about IAAS' strategy and goals in promoting sustainable agriculture.
- 8.2 Complete a research report on the status of sustainable agriculture development in technology, sustainability and investment of your home country.
- 8.3 Complete a business plan proposal including market research and analysis report for the IAAS to review.
